

SRM Joint Entrance Examination for Management (SRMJEEM – MBA) 2025

Frequently Asked Questions.

1. What is the application cost for SRMJEEM 2025?

The application cost is Rs.1200 for each phase of SRMJEEM

2. How many phases are in SRMJEEM 2025?

SRMJEEM 2025 will have 3 phases.

3. When will be SRMJEEM 2025 Entrance exam conducted?

SRMJEEM 2025 - **Phase I** Main Exam: 15.02.2025 SRMJEEM 2025 - **Phase II** Main Exam: 12.04.2025 SRMJEEM 2025 - **Phase III** Main Exam: 14.06.2025

4. What is the mode of Examination?

Mode of Examination will be online (Remote Proctored Online Mode). The student can write the exam from home. The student can attempt the test with desktop or laptop. The student cannot write the exam using Mobile Phone. The test will be AI monitored, as well as proctors and super proctors will be present. The detailed instructions regarding system configuration, Internet speed will be mailed to the students and will be available in the website one week before the exam.

5. How many slots will be available per day during the exam dates?

There will be two slots per day during the exam dates. When the slot booking is open (tentatively 3 days before the start of exam), the student can book convenient slots. Once the slot is booked, the student can download the Hall Ticket.

6. Are there any mock tests conducted?

Yes, there will be a mock test conducted before the main exam. Mock Test can be taken by the students at their convenience.

8. How to Edit the Application form?

Kindly post your query under form correction category for any correction.

9. I have done the payment for application but in portal, status is pending?

Kindly wait for 24 hours or you can post your query under technical query category.

10. What is the mode of payment for Application?

Online payment (Debit card, Credit card, UPI, Net banking).

11. What are the Documents to be uploaded in the Application?

Photo Image, Signature Image and Competitive exam score card (If applicable).

12. Is the Application fee Refundable?

Application fee is Non-Refundable.

13. How to edit the course preference in the application form, which is already submitted?

Course/Campus preference selected at the time of application is only for statistical purposes, the actual course preference can be selected at the time of choice filling based on SRMJEEM – Rank and availability of seats.

14. What is the eligibility for MBA?

- 1.A Bachelor's degree with minimum aggregate of 50%.
- 2. Admission will be done through SRM Joint Entrance Examination for Management (SRMJEEM) followed by a Personal Interview. Students with eligible entrance scores in CAT/XAT/MAT/GMAT/NMAT/CMAT/TANCET will be granted direct consideration for the personal interview
- 3. Preference would be given to candidates with work experience.

^{*}Candidates who do not meet the eligible cutoff score in any of the specified exams are required to mandatorily appear for the SRMJEEM exam.

16. Whether I need to submit separate application for each phase?

Yes, Students are required to submit a separate application for each phase.

17. What is the last date to submit the application form?

SRMJEEM 2025 - Phase I:

Last date for applications- 09.02.2025

SRMJEEM 2025 - Phase II:

Last date for applications- 07.04.2025

18. Will the Personal Interview for each phase be held separately?

The Personal Interview will be held in online mode for each phase separately. Once the candidate has qualified either through the above-mentioned competitive exams or SRMJEEM the candidate will be required to select the campus and program of their choice in SRM's admission portal. Post program selection, candidates will receive a virtual meeting link through their registered email for an online interview with a team of faculty.

19. What happens after the Personal Interview?

Candidates who successfully clear the Personal Interview will receive a Provisional Allotment Offer along with a specified time frame (usually 7-10 days) to pay the initial counselling fee. The admission committee will allocate the campus, program, and specialization based on the candidate's performance in the competitive exam/SRMJEEM, academic credentials, Personal Interview, and other factors. Failure to pay the counselling fee within the given time frame will result in the cancellation of the allotment. After the fee payment, candidates can download their fee receipt and Provisional Allotment Letter (PAL). Candidates will be granted an additional 14 days to pay the remaining balance for the first academic year. SRM reserves the right to modify the amount of the counselling fee and the payment timeline, if required, from time to time. Candidates are advised to stay updated through their registered email and mobile number (SMS/WhatsApp).

20.Is the tuition fee refundable?

Yes, the fees will be refunded as per the norms set by AICTE. Please refer to AICTE website from time to time.

21. What is SRMJEEM Provisional Allotment Letter?

Upon payment of the SRMJEEM registration fee and counselling fee, a Provisional allotment letter and fee receipt will be issued. The Program allotment will be published in the Online Admission Portal (OAP). This Provisional Allotment Letter is accepted by various banks/financial institutions for processing of educational loans if required.

22. Will the SRMJEEM result be available online?

Yes, the SRMJEEM result will be available online. Once the exam is conducted and the results are declared, candidates can check their individual scores on the Admission Portal.

23.Is it compulsory for candidates to appear for all phases of SRMJEEM?

No, it is not mandatory for candidates to appear in all phases of SRMJEEM. However, you can choose to apply for either Phase 1, Phase 2, Phase 3 or all, based on your preference.

24. Is there any negative marking in SRMJEEM?

No, there is no negative marking in SRMJEEM.

25.Do I need to be an expert in computer operations to take the SRMJEEM online exam?

No, you do not need to be an expert in computer operations to take the SRMJEEM online exam. The exam is designed to be user-friendly, and basic computer skills such as using a mouse, keyboard, and navigating through multiple-choice questions are sufficient.

However, it is recommended to familiarize yourself with the online exam interface before the test.SRM provides a mock test or a practice session before the actual exam to help you get comfortable with the format and navigation

of the online test.

26. What are the system requirements for SRMJEEM online exam?

For the SRMJEEM online exam, you will need:

- a. A desktop or laptop with a functional webcam.
- b. Google Chrome or Mozilla Firefox browser installed.
- c. A stable **internet connection** with a minimum speed of 2 Mbps.
- d. A microphone (if needed for verification) and headphones for better sound quality.
