**SRM Joint Entrance Examination for
Law – (SRMJEEEL) 2025**

Frequently Asked Questions:

1. What is the application fee for SRMJEEEL 2025?

The application fee is Rs.1200 for each phase of SRMJEEEL.

2. How many phases are in SRMJEEEL 2025?

SRMJEEEL 2025 will be conducted in 2 phases.

3. When will SRMJEEEL 2025 entrance exam conducted?

SRMJEEEL 2025 (5 Year Integrated Programs)

Phase I Main Exam: 15.04.2025 and 16.04.2025

Phase II Main Exam: 05.06.2025 and 06.06.2025

4. Which programs require the SRMJEEEL (SRM Joint Entrance Examination for Law Program) exam for admission?

- 1) B.A.,LL.B(Hons) - Bachelor of Arts and Legum Baccalareus
- 2) B.Com.,LL.B(Hons) - Bachelor of Commerce and Legum Baccalareus
- 3) B.B.A.,LL.B(Hons) - Bachelor of Bussiness Administrarion and Legum Baccalareus

5. What is the mode of Examination?

Mode of Examination will be online (Remote Proctored Online Mode). The student can write the exam from home. The student can attempt the test with desktop or laptop. The student cannot write the exam using Mobile Phone. The test will be AI monitored, as well as proctors and super proctors will be present. The detailed instructions regarding system configuration, Internet speed will be mailed to the students and will be available in the website one week before the exam.

6. How many slots will be available per day during the exam dates?

There will be one slot per day during the exam dates. When the slot booking is open (tentatively 3 days before the start of exam), the candidates can book the convenient date. Once the date is confirmed, the student can download the Hall Ticket.

7. Are there any mock tests conducted?

Yes, there will be a mock test conducted before the main exam. Mock Test can be taken by the students at their convenience.

9. How to edit the application form?

Kindly post your query under form correction category for any correction.

10. I have done the payment for application but in portal, status is pending?

Kindly wait for 24 hours or you can post your query under technical query category.

11. What is the mode of payment for application?

Online payment (Debit card, Credit card, UPI, Net banking).

12. What are the documents to be uploaded in the application?

Photo Image, Signature Image and Competitive exam score card (If needed)

13. Is the application fee refundable?

Application fee is non- refundable.

14. How to edit the course preference in the application form, which is already submitted?

Course preference selected at the time of application is only for statistical purposes, the actual course preference can be selected at the time of choice filling based on SRMJEEEL – rank and availability of seats.

15. What is the eligibility for Law?

1. A Bachelor's degree with minimum aggregate of 60%.
2. Admission will be done through SRM Joint Entrance Examination for Law (SRMJEEEL) followed by a Personal Interview. Students with eligible entrance scores in CLAT/SAT will be granted direct consideration for the personal interview.

Competitive Exams	Eligible Scores
CLAT	*50 Percentile and above
SAT	*50 Percentile and above

*Candidates who do not meet the eligible cutoff score in any of the specified exams are required to mandatorily appear for the SRMJEEEL exam.

18. Whether I need to submit separate application for each phase?

Yes, Students are required to submit a separate application for each phase.

19. What is the last date to submit the application form?

SRMJEEEL 2025 (5 Year Integrated Programs)

Phase I - Last date for applications - 09.04.2025

Phase II - Last date for applications - 30.05.2025

20. Will the Personal Interview for each phase be held separately?

The Personal Interview will be held in online mode for each phase separately. Once the candidate has qualified either through the above-mentioned competitive exams or SRMJEEEL the candidate will be required to select the campus and program of their choice in SRM's admission portal. Post program selection, candidates will receive a virtual meeting link through their registered email for an online interview with a team of faculty.

21. What happens after the Personal Interview?

Candidates who successfully clear the Personal Interview will receive a Provisional Allotment Offer along with a specified time frame (usually 7-10 days) to pay the initial counselling fee. The admission committee will allocate the program, and specialization based on the candidate's performance in the competitive exam/SRMJEEEL, academic credentials, Personal Interview, and other factors. Failure to pay the counselling fee within the given time frame will result in the cancellation of the allotment. After the fee payment, candidates can download their fee receipt and Provisional Allotment Letter (PAL). Candidates will be granted an additional 14 days to pay the remaining balance for the first academic year. SRM reserves the right to modify the amount of the counselling fee and the payment timeline, if required, from time to time. Candidates are advised to stay updated through their registered email and mobile number (SMS/WhatsApp).

22. Is the tuition fee refundable?

Yes, the fees will be refunded as per the norms set by UGC. Please refer to UGC website from time to time.

23. What is the Provisional Allotment Letter?

Upon payment of the SRMJEEEL registration fee and counselling fee, a Provisional allotment letter and fee receipt will be issued. The Program allotment will be published in the Online Admission Portal (OAP). This Provisional Allotment Letter is accepted by various banks/financial institutions for processing of educational loans if required.

24. Will the SRMJEEEL result be available online?

Yes, the SRMJEEEL result will be available online. Once the exam is conducted and the results are declared, candidates can check their individual scores on the Admission Portal.

25. Is it compulsory for candidates to appear for all phases of SRMJEEEL?

No, it is not mandatory for candidates to appear in all phases of SRMJEEEL. However, you can choose to apply for either Phase 1 or Phase 2 or both phases based on your preference.

26. Is there any negative marking in SRMJEEEL?

No, there **is no negative marking** in SRMJEEEL.

27. Do I need to be an expert in computer operations to take the SRMJEEEL online exam?

No, you do not need to be an expert in computer operations to take the SRMJEEEL online exam. The exam is designed to be user-friendly, and basic computer skills such as using a mouse, keyboard, and navigating through multiple-choice questions are sufficient. However, it is recommended to familiarize yourself with the online exam interface before the test. SRM provides a mock test or a practice session before the actual exam to help you get comfortable with the format and navigation of the online test.

28. What are the system requirements for SRMJEEEL online exam?

For the SRMJEEEL online exam, you will need:

- a. A **desktop or laptop** with a functional **webcam**.
- b. **Google Chrome** or **Mozilla Firefox** browser installed.
- c. A stable **internet connection** with a minimum speed of 2 Mbps.
- d. A **microphone** (if needed for verification) and **headphones** for better sound quality.
