1.	95 th Percentile and above	Merit Scholarship 100%	100% Tuition Fee Waiver
2.	90 th Percentile to 94.99 th Percentile	Merit Scholarship 75%	75% Tuition Fee Waiver
3.	85 th Percentile to 89.99 th Percentile	Merit Scholarship 50%	50% Tuition Fee Waiver
4.	80 th Percentile to 84.99 th Percentile	Merit Scholarship 25%	25% Tuition Fee Waiver

II. Diversity Scholarship

S. No.	Category	Benefit
1.	Gender Diversity	5% Tuition Fee Waiver
2.	Regional Diversity	5% Tuition Fee Waiver

Diversity scholarships are offered in addition to any one of the other SRM Merit scholarship obtained by the candidate. If a candidate is eligible for more than one merit scholarship, the highest of the scholarship will be considered.

a. Regional Diversity:

Candidates from outside Tamil Nadu/Puducherry as per their Aadhaar will get 5% scholarship in their tuition fee as waiver.

b. Gender Diversity:

All Female candidates will get 5% scholarship in their tuition fee as waiver.

Examples:

1. Candidate A – Female from outside Tamil Nadu/Puducherry as per their Aadhaar and has scored 92nd percentile in their CUET PG will get a total scholarship of 75% + 5% + 5% = 85% scholarship in their tuition fee as waiver.
2. Candidate B – Male from outside Tamil Nadu/Puducherry as per their Aadhaar but has not secured any of the above Merit scholarships will get 5% scholarship in their tuition fee as waiver

Important Note:

1. All Scholarships will be processed after enrollment in the first year, upon successful verification of all required documents. Any fees paid will be reimbursed or adjusted against the fees for subsequent years, as applicable.

Conditions for Renewal:

1. Renewal upon application within the stipulated date every year
2. No arrears (or) backlogs at the time of application
3. No break in studies / detention /disciplinary actions / Malpractice
4. Must possess the required CGPA as stipulated below
 - a. Merit Scholarship - 8 CGPA
 - b. Gender / Regional Diversity Scholarship – 7 CGPA
