Over the last decade, JGU has grown into an institution that brings full-time faculty from 50+ countries in the world, students from 75+ countries and has collaborated with 525+ leading institutions in 80+ countries which makes the learning experience truly international.

JGU is ranked Number 1 in the world with the highest overall score amongst all universities and awarded 'Gold' by the Times Higher Education (THE) Online Learning Rankings 2024. JGU has been ranked as India's Number 1 Private University for three years in a row by the prestigious QS World University Rankings 2023. JGU has been recognised among the Top 150 universities globally under the age of 50 years by the QS Young University Rankings. JGU has also been recognised in the Top 500 Universities as per the QS Graduate Employability Rankings 2022.

The Jindal Global Law School, has retained its number one rank in India for six consecutive years and remains the only Indian law school listed in the Global Top 100 by the QS World University Rankings by Subject 2025. 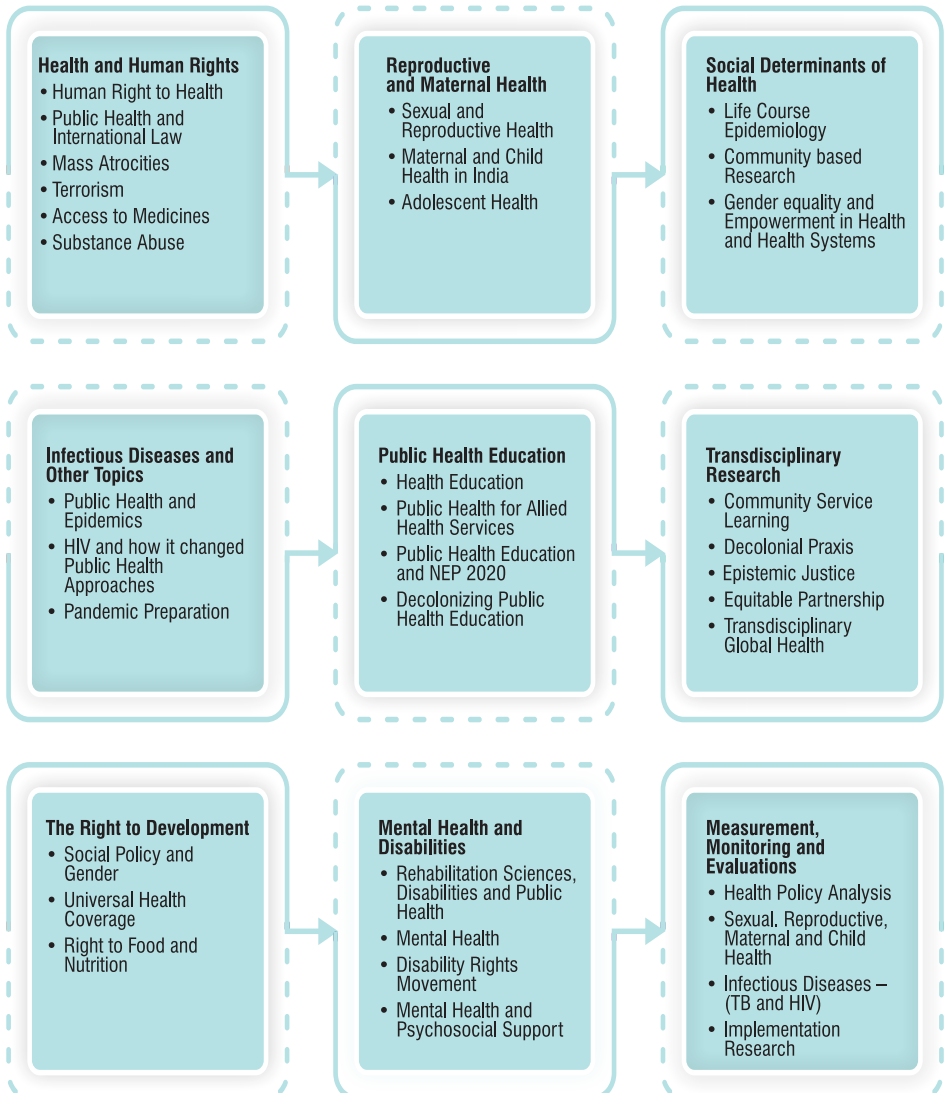

Swati Narayan, Associate Professor at JSPH, received a mention in a Rajya Sabha discussion for her book Unequal.

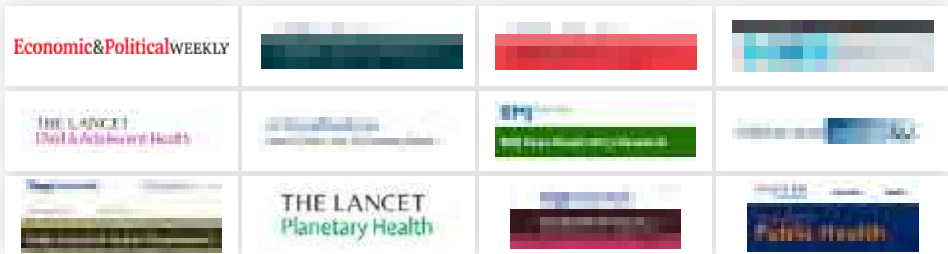

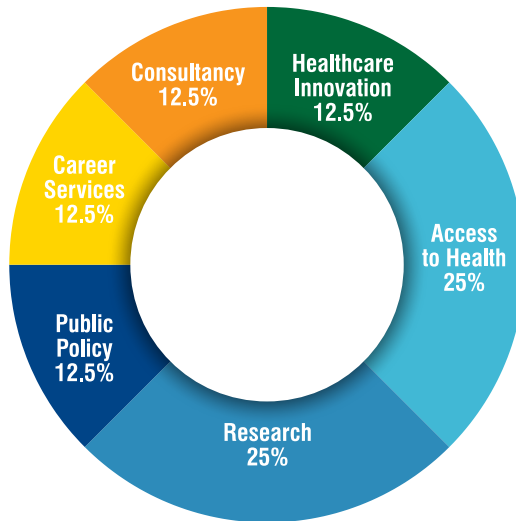

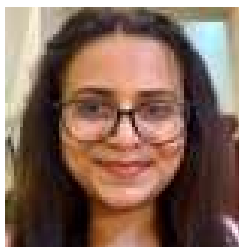


Students Stories

In 2024, I interned with the National AIDS Control Organisation (NACO) under the Ministry of Health and Family Welfare, Government of India, to explore the strategies used to combat HIV/AIDS in India. My work focused on conducting a secondary data analysis of factors associated with unsuppressed viral loads among pregnant women living with HIV in Andhra Pradesh. This involved examining socio-economic factors, healthcare access, and treatment adherence to identify gaps in care and recommend improvements. I also participated in NACO's broader initiatives, including the SAMPARK 2.0 program, ART center visits, and training on integrated HIV and NCD services, gaining valuable insights into holistic HIV care.

I interned with Child Rights and You (CRY), an organization dedicated to the safety and well-being of children. During my time there, I worked under the Policy Resource and Documentation (PRAD) team, focusing my research on child and maternal health indicators in South Indian states from 1998 to 2010. Additionally, I interned with the Pratichi Institute, part of the Pratichi (India) Trust established by Nobel Laureate Professor Amartya Sen. My work centered on the PM POSHAN (mid-day meal) scheme in West Bengal, promoting school nutrition gardens, and analyzing a survey on their benefits and women's political participation in the state.

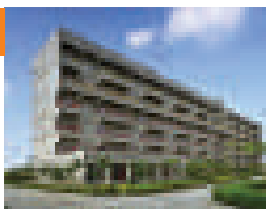

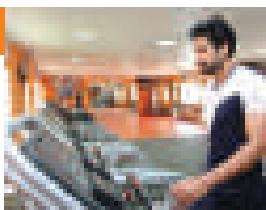

Admission Requirements & Fees Structure

Programme: Master in Public Health

Course Duration: 1 Year

Minimum Eligibility: Successful completion of a Bachelor's degree in any stream from a recognized university in India or abroad. Students with a foreign medical degree (without FMGE qualification) are encouraged to apply. *Please note:* Students with any other International Bachelor's degree, must submit an equivalency certificate from the Association of Indian Universities (AIU).

JGU follows a three-stage admission process:

1. Evaluation of the application form including Personal Statement
2. Online Entrance Test/ Score of listed national or international entrance test
3. Personal Interview (Online mode)

Tuition Fee ₹ 2,50,000/- per annum*

Refundable Security Deposit ₹ 50,000/-**

Application Fee ₹ 1,000/-

*The Tuition fee, Accommodation charges and other allied service charges are subject to an annual increase of upto 10%.

**Fully refundable Security deposit of Rs. 50,000 shall be collected at the time of admission as per university rules.

Accommodation Charges – 2,18,000 per annum.

Other Allied Service Charges – 1,17,000 per annum. (Other Allied Services including but not limited to food, Laundry, Security Services, Housekeeping charges, electricity etc.)

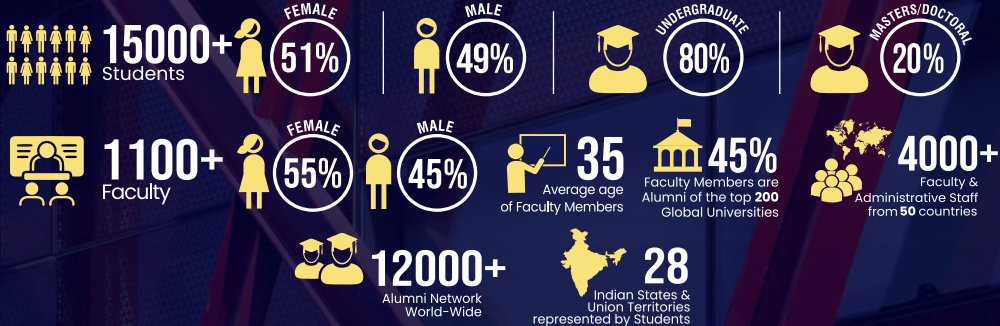
