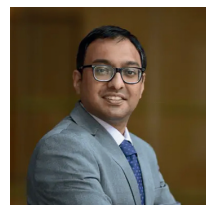

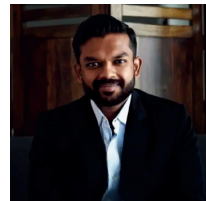

**B.A. LL.B. (Hons.)**

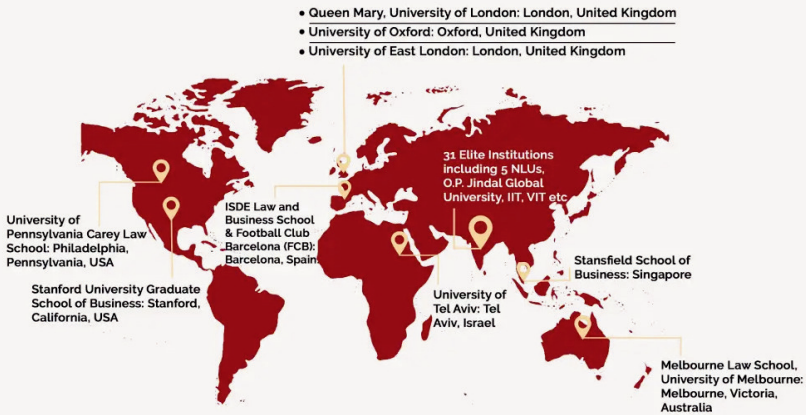

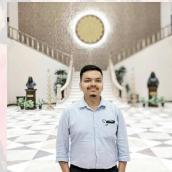
