Online Counselling Notice on the basis of JEE Main – 2024 Merit
AND
Update regarding new branch BE (Artificial Intelligence & Machine Learning)

This is for the information of the candidates that the Institute has got the AICTE approval of starting BE – AIML (Artificial Intelligence & Machine Learning) a new BE programme w.e.f. the current session 2024-25. Admission to this programme will be offered in the third round of online counselling along with vacant seats of other programmes. The candidates are advised to modify the preference order if interested in BE-AIML on or before the cut-off date i.e. 12th July, 2024.

The third round of online counselling for the vacant seats of BE/BTech programme will be held on 17th July, 2024 on the basis of JEE Main – 2024 merit. All the candidates who have already applied or will be applying till 12th July, 2024 shall be considered for this round of counselling subject to fulfilment of eligibility criteria prescribed in the prospectus 2024-25. Please note:

- 1. The Institute advises candidates admitted in earlier rounds to apply for the withdrawal in case they have decided for not continuing their admission at TIET so that their fee refund can be processed timely. Refund processing timelines are available as hereunder:**

Date of Admission Withdrawal	Tentative time to process the refund
On or before July 15 th , 2024	15-20 days
On or before the start of classes i.e. August 5 th , 2024	30-45 days
After August 5 th , 2024	60-90 days

2. Third round will be held in online mode i.e. candidates are not required to visit the campus. Branch/Category wise cut-off details will be published on the website.
3. Third round of Counselling will be held on the basis of JEE Main - 2024 merit. Candidates are advised to update their JEE Main - 2024 details in their online application form if not done already on or before the cut-off date i.e. 12th July, 2024.

4. Candidates will be offered branch provisionally. Admission will be confirmed subject to fulfilment of the eligibility conditions mentioned in Prospectus 2024-25 (available at <https://admission.thapar.edu/>) during the document checking.
5. Candidates will be able to check their branch allocation status on an online portal after 5:00 PM (tentatively) on 17th July, 2024. In case of any change in the time, same will be published on the website.
6. Selected candidates will be required to pay the requisite fee by **24th July, 2024**.
7. Online application form will remain close from 12th July, 2024 till 18th July, 2024. It will be made available for new applications from 19th July, 2024 onwards for the subsequent rounds of counselling.
8. During the counselling, Branch allocation will be as per the merit, category wise seat availability and branch preference order filled in the application form. Candidates are advised to re-check all the details (especially the branch preference order) in the application form before the last date i.e. 12th July, 2024.
